Mr. Cook and Mr. Outwater offered the following, and moved its adoption: WHEREAS, the "Right to Bear Arms" is guaranteed by the 2nd Amendment to the United States Constitution, and

WHEREAS, certain bills passed in the New York State Assembly will have a detrimental effect on hunters, sportsmen and legal gun owners as well as the health of wildlife, revenue to local municipalities and the Department of Environmental Conservation, and

WHEREAS, passage of said legislation would curtail the rights of law abiding citizens as guaranteed by the Constitution,

NOW, THEREFORE, be it

RESOLVED, That the Chenango County Board of Supervisors hereby urges the New York State Senate and the Governor to oppose the following bills:

- A. 801-A/S.1598A An act to amend the penal law, in relation to providing for the expiration and renewal of certain firearms licenses outside the city of New York
- A. 1093/S. 1715 An act to amend the general business law and the penal law, in relation to preventing the sale of firearms, rifles, and shotguns to criminals
- A. 1326/ S. 5228 An act to amend the penal law, in relation to the sale of child operated firearms
- A. 2881/ S. 2379 An act to amend the penal law, in relation to the possession of armor piercing, frangible or devastator ammunition
- A. 2882-A/ No Senate bill An act to amend the executive law, in relation to the compilation of firearm and ballistic data
- A. 3076-B/S. 5489 An act to amend the penal law, in relation to the issuance of a license to carry a firearm
- A. 3211/S. 4752 An act to amend the penal law and the executive law, in relation to banning the sale, possession or use of 50-caliber weapons
- A. 5844/ S. 3098 An act to amend the penal law, the general business law and the education law, in relation to criminally negligent storage of a weapon and weapons safety programs for children
- A. 6157/ No Senate bill An act to amend the penal law and the general business law, in relation to banning the possession, sale or manufacture of
