President's Message



Smith and Wesson had made several attempts at marketing centerfire semiautomatic handguns over the years. It wasn't until 1955 that the company met with success.

In the late 1940s, the U.S. military announced an interest in replacing its standard issue Colt 1911A1 pistols with a double action 9 mm handgun. This would become the U.S. Army service pistol trials of 1954.

At the end of the trial, no pistol was selected and the U.S. military would retain the 1911A1 until 1984 when it was replaced with the Beretta M9.

Smith & Wesson put significant effort into its entry (the Model 39) and when the trial ended it was released on the civilian market to considerable interest.

The Model 39 is a single stack, eightround capacity, double action, 9 mm pistol with an aluminum frame, steel slide, wood grips, blued finish and adjustable rear sights.

In 1967, the Illinois State Police adopted the Model 39 as its standard

issue sidearm. This both secured Smith & Wesson's first major contract for semi-automatic pistols, and also generated considerable commercial interest from the public at large.

Production of the Model 39 ended with the Model 39-2 in 1982 with serial number A747148.

Interestingly, the initial production of Model 39s made in the mid-1950s had steel frames. Less than 1,000 of this variant were made and they weren't assembled or sold until the mid-1960s.

There were a number of small-batch production variations of the Model 39. These included some purchased by the U.S. military during and after the pistol trial.

There was also a special 14-shot suppressed version for use in Southeast Asia. Officially called the Mark 22 Model 0, it's better known by its nickname "Hush Puppy" for one of the intended uses, silencing guard dogs. This model also had a unique slide lock that prevented the slide from reciprocating. This enabled it to be fired as a single shot.

The Venezuelan government purchased a small lot of Model 39 pistols in 1975. There were a couple of dozen production overruns from this contract sold in the U.S. These can be identified by the Venezuelan Crest on the right side of the slide. Needless to say, these are extremely rare.

Around 700 pistols were made in 1979 as Connecticut State Police commemoratives. This is the only known Model 39 commemorative produced by Smith & Wesson.

There also are reports of approximately 500 pistols marked 7.65 Parabellum produced without barrels and shipped to West Germany where .30 Luger barrels were fitted. These pistols were shipped to Italy for commercial sale.

From the 1970s through the early 1980s, Armament Systems and Procedures produced a custom "chopped" version of the Model 39 as one of the first compact full power

auto loading pistols. They featured a shortened barrel and slide, grip panels with transparent inserts, magazines cut with matching viewing ports, a special Teflon finish, bobbed hammers and the unique "Guttersnipe" sight for close range snap shooting. Estimates are that less than 3,000 were made.

Another unusual version of these handguns was the Model 52 manufactured from 1961 through 1993. The Model 52 was chambered for .38 Special flush seated wadcutters, and fed from a five-round magazine. These were intended for use in competition shooting events such as Bullseye and were popular.

The next major innovation in this series was the Model 59. Based on the

Mk 22 Mod 0 Hush Puppy mentioned above and starting production in 1971, this pistol married the proven Model 39 fire control system with a 14-round capacity, double-stack magazine. This made the Model 59 the first of the so called "wonder nines" that eventually dominated the commercial and law enforcement markets.

Unfortunately, the feel, fit and finish of the Model 59 was considered inferior to that of the Model 39 and production of the Model 59 also ended in 1982.

Smith & Wesson produced a few other models in what became known as its first generation series of semi-automatic handguns. Starting in the late 1970s, the first of the second generation

pistols began to hit the market. But, that's a story for another time.

The Standard Catalog of Smith & Wesson, by Jim Supica and Richard Nahas, is still in print and is considered the primary resource for Smith & Wesson collectors.

White House Ceremony, June 25, 2019

The President of the United States of America, authorized by Act of Congress, March 3rd, 1863, has awarded in the name of Congress the Medal of Honor to Staff Sergeant David G. Bellavia, United States Army, for conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty.

Staff Sergeant David G. Bellavia distinguished himself by acts of gallantry and intrepidity above and beyond the call of duty on November 10, 2004, while serving as squad leader in support of Operation Phantom Fury in Fallujah, Iraq.

While clearing a house, a squad from Staff Sergeant Bellavia's platoon became trapped within a room by intense enemy fire coming from a fortified position under the stairs leading to the second floor. Recognizing the immediate severity of the situation, and with disregard for his own safety, Staff Sergeant Bellavia retrieved an automatic weapon and entered the doorway of the house to engage the insurgents.

With enemy rounds impacting around him, Staff Sergeant Bellavia fired at the enemy position at a cyclic rate, providing covering fire that allowed the squad to break contact and exit the house.

A Bradley Fighting Vehicle was brought forward to suppress the enemy; however, due to high walls surrounding the house, it could not fire directly at the enemy position. Staff Sergeant Bellavia then re-entered the house and again came under intense enemy fire. He observed an enemy insurgent preparing to launch a rocket-propelled grenade at his platoon. Recognizing the grave danger the grenade posed to his fellow soldiers, Staff Sergeant Bellavia assaulted the enemy position, killing one insurgent and wounding another who ran to a different part of the house.

Staff Sergeant Bellavia, realizing he had an un-cleared, darkened room to his back, moved to clear it. As he entered, an insurgent came down the stairs firing at him. Simultaneously, the previously wounded insurgent reemerged and engaged Staff Sergeant Bellavia. Staff Sergeant Bellavia, entering further into the darkened room, returned fire and eliminated both insurgents. Staff Sergeant Bellavia then received enemy fire from another insurgent emerging from a closet in the darkened room.

Exchanging gunfire, Staff Sergeant Bellavia pursued the enemy up the stairs and eliminated him. Now on the second floor, Staff Sergeant Bellavia moved to a door that opened onto the roof. At this point, a fifth insurgent leapt from the third floor roof onto the second floor roof. Staff Sergeant Bellavia engaged the insurgent through a window, wounding him in the back and legs, and caused him to fall off the roof.

Acting on instinct to save the members of his platoon from an imminent threat, Staff Sergeant Bellavia ultimately cleared an entire enemy-filled house, destroyed four insurgents, and badly wounded a fifth. Staff Sergeant Bellavia's bravery, complete disregard for his own safety, and unselfish and courageous actions are in keeping with the finest traditions of military service and reflect great credit upon himself and the United States Army.

Why Much More than NYC's Absurd Gun Laws Are in the Balance

Sometimes, even in this hyperbolic age of partisan media madness, the most impactful events are lost on the public and obscured in legal details.

The Second Amendment case the U.S. Supreme Court has opted to hear, *New York State Rifle & Pistol Association v.*New York, is such a situation.

In the past few weeks, the list of friend-of-the-court briefs (what lawyers call "amici curiae") attached to the case has grown substantially. Even the U.S. government has chosen to give its legal opinion to the justices.

Officially, the court will decide:
"Whether New York City's ban
on transporting a licensed, locked
and unloaded handgun to a home
or shooting range outside city
limits is consistent with the Second
Amendment, the commerce clause and
the constitutional right to travel."

This case likely will be heard this fall and decided next spring. The ruling may focus on a relatively narrow issue about whether the city's law is constitutional, but it also could decide on the broader issue of whether, and to what extent, the right to have a gun extends outside the home. The court also might provide an analytical framework that lower courts can use in future Second Amendment cases. The lower courts resistance to the landmark Heller and McDonald decisions has been the biggest impediment to advancing gun rights in the courts.

The possibility that the Supreme Court justices could answer questions like that have anti-Second Amendment-freedom groups so worried they are

asking the court to please not answer the constitutional questions. In fact, in its friend-of-the-court brief, the Brady Campaign to Prevent Gun Violence even calls the entire court challenge moot 10 times, as it argues that New York City is tweaking its gun restrictions to avoid this constitutional challenge in the first place.

That this request for review from the New York State Pistol and Rifle Association and a group of gun owners who live in New York City will be heard by the high court was actually a surprise.

It shouldn't have been. The plaintiffs in this case are challenging New York City's ban on transporting even licensed, unloaded and locked-up guns anywhere outside the city limits—to say a weekend home or a gun range, and even to another residence in NYC—for those who have a "premises license." People with premises licenses can only move a handgun if they somehow obtain prior, written permission from the NYC police commissioner.

The U.S. government's friend-of-the-court brief on this case points out this not only violates the Second Amendment, but also violates the dormant Commerce Clause. The U.S. government shows the absurdity of NYC's laws by quoting NYC's claim that this isn't an unreasonable restriction because a resident could "buy, rent or borrow new guns to use at those locations."

"The Second Amendment, however, protects a right to keep and bear

arms, not just a right to rent or borrow them," says the U.S. government.

The Bigger Questions

The NRA, in its friend-of-thecourt brief, begins with the fundamental question of how our Second Amendment rights should be weighed when judging if a law is unconstitutional, as NYC's clearly are.

"In District of Columbia v. Heller, this Court made clear that infringements on the individual right to keep and bear arms for self-defense are to be analyzed by comparing them against the Second Amendment's text and history—not under an 'interestbalancing inquiry' like one of the so-called 'tiers of scrutiny," says the NRA. "After all, the Second Amendment 'is the very product of an interest balancing by the people,' and the government—'even the Third Branch of Government'—has no warrant to recalibrate the balance the People struck because judges conclude that a sufficiently 'important' or 'compelling' governmental interest shows that the right is not 'really worth insisting upon."

"In the decade since this opinion was handed down, most lower federal courts have openly flouted these instructions. They have constructed a Second Amendment jurisprudence based upon the very interest-balancing inquiry this Court rejected—an 'intermediate scrutiny' analysis that routinely finds Second Amendment rights outweighed by little more than the government's say so that the rights

must be eclipsed in the name of public safety."

The NRA later says, "This approach is contrary to the text and purpose of the Second Amendment—which was enshrined in our Constitution because the People already weighed the competing interests at stake, and solemnly concluded that 'the right of the people to keep and bear Arms, shall not be infringed."

For example, the Brady Campaign is trying to sway justices with claims that average people can't be trusted with their rights: "Guns turn quotidian confrontations into deadly affrays, especially when carried by people who lack impulse control or are under the influence of alcohol ... Everyday annoyances at drivers in traffic quickly become murders when guns are in cars."



In this particular case, NYC has effectively banned citizens' Second Amendment rights since it has made it nearly impossible for lawabiding residents to utilize their constitutionally protected right to bear arms.

Reading the friend-of-the-court briefs from the anti-gun groups makes it clear they understand the absurdity and unconstitutionality of NYC's laws, and those in many other states and cities.

The evidence, of course, shows this not to be the case as millions of Americans now carry concealed.

The U.S. government, under the Trump administration, meanwhile, reminds the court: "In *District of Columbia v. Heller*, this Court held that the Second Amendment protects the right of a law-abiding, responsible citizen to keep a firearm in his home for lawful purposes, such as self-defense. In this case, the Court should confirm that the Second Amendment

also protects the right of a law-abiding, responsible citizen to take his firearm outside his home, and to transport it to other places—such as a second home or a firing range—where he may lawfully possess that firearm. The Second Amendment guarantees both the right to 'keep' and the right to 'bear' firearms."

The U.S. government also says, "Read naturally, the right to 'bear' firearms includes the right to transport firearms outside the home; otherwise, the right to 'bear' would add nothing to the right to 'keep' In addition, the right to 'keep' arms, on its own, implies the right to transport firearms between the home and at least some places outside the home—for instance, the place of purchase, the repair shop, and the firing range."

Common sense and previous Supreme Court precedents clearly show NYC—and by default some other jurisdictions—are clearly infringing on citizens' Second Amendment rights. We'll keep you up to date on what happens as this case goes forward.

Minuteman

On the evening of April 18, 1775, the Governor of Massachusetts, General Gage, ordered 700 British soldiers (known as Redcoats) under the command of Lt. Col. Francis Smith to march to Concord, Mass. Their primary mission was to confiscate or destroy the arms and ammunition owned by the citizens of the town. Their secondary mission was to arrest John Hancock and Sam Adams, who were to be hanged after trial.

Dr. Joseph Warren, upon learning of the mission, called for Paul Revere and William Dawes to spread the alarm to the citizens. William Dawes rode south through the Roxbury Neck. Paul Revere had lit the lanterns in the Old North Church, crossed the Back Bay by boat to Charlestown, and triggered the system of alarm riders, signal fires and church bells that were developed to warn the countryside.

The Redcoats crossed the Back Bay later on the night of April 18 and began their march to Concord. On the morning of April 19, around 5 a.m., the Redcoats lead by Lt. Jesse Adir entered the town of Lexington, Mass. The townspeople had elected John Parker, a farmer, to be the captain of the Lexington Training Band. On a side road to the right of the main Boston–Concord road, Capt. Parker and his neighbors waited, standing on their village green in political protest, having been warned by Paul Revere.

Upon seeing the townspeople on the village green, Lt. Adir turned the Redcoat column to the right, confronting Capt. Parker's men and ordering them to lay down their arms and disperse. Greatly outnumbered and not wishing to sacrifice his men, Capt. Parker gave the order to go home. As they turned to leave, the Redcoats opened fire with a raged killing volley and charged the townspeople with bayonets. Lt. Col. Smith then arrived at the head of the column to see that his officers had lost all control as the Redcoats pursued the townspeople into homes and buildings. He ordered a drummer to play recall and his men broke pursuit and assembled into ranks. They were allowed to fire a victory volley and give three cheers of Huzzah before they turned to resume the march to Concord, leaving behind eight dead townspeople on the village green.

Isaac Davis, a farmer and blacksmith in Acton, Mass., had been elected as captain of the Acton Militia. In the early hours of the morning of April 19, he walked out his doorway into the darkness. His wife, Hanna, feared that she would never see him again. He walked with his friends and neighbors across the valleys and fields to a hill outside of Concord. Around 10:30 a.m., Capt. Isaac Davis marched his men off that hill and into history. The Redcoats guarding the North Bridge, opened fire on the militia. The militia returned fire, killing most of the Redcoat Officers at the North Bridge, causing the pride of the British Army to break and run for the town.

At about noon, the brigade of Redcoats under Lt. Col. Smith left Concord and headed east to Boston. They had flankers out on the sides of the column that came back to the center to cross the bridge just before Meriams Corner. On the hillside at Meriams Corner, the militia lay in wait. They fired early as the Redcoats cleared the bridge. The

Redcoats charged and the militia stood their ground driving the flankers back to the road. They hit the Redcoats at Meriams Corner, Brooks Hill, Brooks Tavern, Bloody Angle, Hartwell/ Masons, Parker's Revenge, The Bluff, Fisk Hill and Concord Hill the last hill before the town of Lexington. The militias' numbers had grown to about 2,000. They were chewing hard at the tail of the Redcoats and hitting them hard at the head in the ambushes. The Redcoats were bloody, battered and out of ammo. All of the officers had been wounded. It seemed that the militia would finish them off on the very Lexington Green at which they started, BOOM!!! Came the blast of a cannon. One thousand reinforcements commanded by General Lord Percy had arrived from Boston.


The Redcoats columns combined forces to continue east to Boston under an unending ring of militia fire that was directed by a farmer from Roxbury named Heath. But for a fluke of luck, the Redcoats would have died with their backs against the water, but that was not to be. A quick turn at Kent Lane brought them under the covering guns of a warship in the Back Bay. The militia held back and the Redcoats were evacuated across the water during the dark of night.

The Redcoats suffered 73 KIA/174 WIA/26 MIA. The militia suffered 49 KIA/39 WIA/5 MIA.

The town of Menotomy, Mass. was the scene of some of the bloodiest fighting of the day. A man by the name of Samuel Whittimore, was 80 years old when he took on the brigade of Redcoats by himself. He killed three before they shot him, bayoneted him

14 times and left him for dead. His friends found him and took the old man to a doctor who refused to treat him. "Your friend will die, others I may be able to save." And Samuel Whittimore died 18 years later at the age of 98! Did he wish to die or wish to live? What did he believe in so strongly? Liberty!

And, did Hanna Davis ever see her husband again? Yes, she did. When they brought him home for her to bury. On April 19, 1775, around 10:30 a.m. Capt. Isaac Davis became the first American officer killed in the line of duty. His image is forever immortalized as the Minuteman. The symbol of the Minuteman, which we all know so well, one hand on the musket and one hand on the plow. His name is Isaac Davis.

It was almost two decades since I fired a rifle shot in any sort of formal competition. Over the winter, I decided—or maybe I was nudged by NYSRPA High Power Director George Kline—to rejoin the ranks of the rifle competition world. I have had to adjust to a new bolt release and optic on a once bare rifle I knew well. Shooting coats have gotten more sophisticated and so have barrels and bullet technology. My winter months skiing were filled with wonderings about why I had been drawn back to where my shooting started in my youth.

People compete for a variety of reasons; many I know chase a particular discipline until reaching some high point and then switch disciplines. I have my top three reasons:

First, I relish the opportunity to stress myself against other competitors and the clock. I remember years when the thought of competing made my stomach churn. The wet palms and cotton mouth I got as I walked to the line. I remember the most of my years pleading with my parents not to watch me shoot. Almost 30 years of different levels of competing across many disciples, I still struggle to keep a clear head. Thoughts about dating and high school exams have been replaced with concerns about a pending customer PO or my young daughter.

The end result of this stress inoculation is a person who can think more level headed at times of real stress like, parenting, fire department responses and business negotiations. It is unreal to think that pushing to meet a time limit or comply with a regulation in your hobby can apply in business. Even a friendly Wednesday afternoon



of sporting clays with your friends can increase your competitive spirit. Human brain chemistry is positively boosted when we excel under stressful situation and learn to curb anxiety.

Second, is simply skill at arms. I have watched good target shooters fall to pieces and drop pistols when they were

Following is a little history on an American woman who was a great shooter. I hope you enjoy it.

I think all of us have heard many stories about Annie Oakley. Here are some facts that you may not know. Annie was born Phoebe Ann Moses on Aug. 13, 1860, in Darke County, Ohio. She was called Annie by her family. This unassuming woman, who would perform before royalty and a president, came from humble beginnings. When she was six years old her father died of pneumonia leaving her mother with six children to raise. Her mother remarried and had another child, but her second husband died soon after leaving her with another child to raise. At the age of eight or nine Annie went to live at the Darke County Infirmary, which housed the elderly, the orphaned and the mentally ill. In exchange for helping with the children, Annie received an education and learned the skill of sewing, which she would later use to make her own costumes. At the age of 13 or 14, Annie returned to her family. Her mother had remarried, but the family finances were still marginal. Annie used her father's old Kentucky rifle to hunt small game for the Katzenberger Brother's grocery store in Greenville, Ohio where it was resold to hotels and restaurants. Annie was so successful at hunting that, when she was 15 years old, she was able to pay the mortgage on her mother's house.

Annie's noted shooting ability brought an invitation from Jack Frost, a hotel owner in Cincinnati who had purchased her game, to participate in a shooting contest against a well-known marksman, Frank E. Butler. Butler was on tour with several other marksmen. While on the road, he typically offered challenges to local shooters. Annie won the match with 25 shots out of 25 attempts. Butler missed one of his shots. This amazing girl entranced Butler, and the two shooters began a courtship that resulted in marriage on Aug. 23, 1876.

Annie and Frank Butler first appeared in a show together in May of 1882. She had taken the stage name of Oakley, but off stage she was always Mrs. Frank Butler. At a March 1884 performance in St. Paul, Minn., Annie befriended the Lakota leader Sitting Bull. The victor over George Armstrong Custer at the 1876 Battle of Little Big Horn, Sitting Bull was impressed with Oakley's size (she was only five feet tall), her shooting skills, her modest appearance, and her self-assured manner. They became fast friends. It was Sitting Bull who dubbed her "Watanya Cicillia" (English translation: "Little Sure Shot"). The American Indian warrior liked her so much that he gave her his special moccasins to "adopt" her as his daughter.

In 1885, Oakley joined Buffalo Bill's Wild West Show. This was a significant turning point in Annie Oakley's life and in her relationship with Butler. Until this time, either Butler had received top billing or they had shared the limelight. However, with the Wild West Show, Oakley was the star. It was her name on the advertising posters as "Champion Markswoman." Butler happily accepted the position as her manager and assistant. Oakley and Butler prospered with the Wild West Show

and remained with the show for 16 years. They toured Paris, France, Italy and Spain with the Wild West Show.

Oakley and Butler's desire for less extensive traveling—as well as a serious train accident that injured her back— caused them to leave the show in 1901. However, she continued to perform. Then, Butler signed a contract as a representative for the Union Metallic Cartridge Co. in Connecticut. This was a position that allowed them both to make endorsements for the company and to continue their shooting exhibitions. Finally in 1913, the couple retired from the arena and settled down in Cambridge, Md.

When the U.S. was pulled into World War I in 1917, Oakley offered to raise a regiment of woman volunteers to fight in the war. She had made the same offer during the Spanish-American War; neither offer was accepted. She also volunteered to teach marksmanship to the troops. Oakley gave her time to the National War

Council of the Young Men's Christian Association, War Camp Community Service and Red Cross.

Oakley began making plans for a comeback in 1922. Attracting large crowds in Massachusetts, New York, and major cities, she had plans to star in a motion picture. Unfortunately, at the end of the year, she and Butler were severely injured in an automobile accident in Florida. It took Oakley more than a year to recover from her injuries and she had to wear a leg brace. By 1924, she was performing again, but her recovery did not last long. By 1925, she was frail and in poor health. She and Butler moved to her hometown in Ohio to be near her family. They attended shooting matches in the local area, and Oakley began to write her memoirs, which were published in newspapers across the country.

In 1926, after 50 happy years of marriage, and long adventuresome lives the Butlers died. Oakley died from pernicious anemia on Nov. 3,



at the age of 66. Butler mourned so deeply, he stopped eating and died 18 days later on Nov. 21. This remarkable woman is remembered as a western folk hero, American legend and icon. Throughout her career, Oakley maintained her dignity and propriety while quietly proving that she was superior to most men on the shooting range. Thanks to Hollywood and history, the legend of Annie Oakley endures.

One of Annie Oakley's famous quotes was, "I would love to see every woman know how to handle guns as naturally as they know how to handle babies."

After a Defensive Shooting: What to Do

You have just been attacked by an armed criminal and forced to deploy your defensive handgun. Too often, people who prepare for such a possibility fail to consider what they should do and what they should expect once the gunfire has ceased. Dealing with the aftermath of such an unfortunate situation should be a critical part of your personal defense plan. To fail to consider it can place you in a good deal of legal and physical danger. Once the shooting is over, you should put your gun away and call 9-1-1 immediately.

When you call 9-1-1, you should give your name, location and a very brief description of what has just occurred ("A man tried to rob me with a gun and I had to shoot him"). You should ask that an ambulance and law enforcement be dispatched right away. It is not your responsibility, nor are you trained to determine, if your attacker is still alive. Assume that he is and get him some medical attention.

You should understand that 9-1-1 lines are recorded, and that recording can be produced as evidence in court. For that reason, in your stressed-out mental state, it is not a good idea to try to explain the various details of what happened. The time for that will come later, after you have consulted with an attorney and had an opportunity to calm down.

You should also understand that, if you are still holding your gun when the police arrive, you stand a very good chance of being shot. Police officers cannot tell the good guys from the bad guys by simply looking at you. If they see a gun in your hand, they must

assume that you represent a threat to them.

Just a few years ago, in a Southwest city, police shot a man whose wife had told them on the phone that he was the good guy who was holding a gun on a home invader. When the first officer arrived on the scene, the wife told him the same thing. The officer promptly went into the house and shot her husband nine times. Police officers can be stressed and confused, too.

We teach defensive students to only reholster their guns when peace has been restored to their immediate area. However, there may be times when the shooting has stopped but you still don't feel very safe—the attacker may have friends or relatives nearby. In this case it is best to get away from the scene. You don't necessarily have to go far. You may just create some distance and get behind good cover to await the arrival of law enforcement. Just do your best not to have the gun in your hand when they arrive.

Keeping in mind that the police don't know what has happened and don't know the players, don't be surprised if you are ordered to lie face-down on the ground. And, if that happens, you will more than likely be handcuffed as well. This doesn't mean that anyone automatically thinks that you are guilty. What it means is that the police officers are going to make doubly sure that the trouble is over, and that no one else is about to get hurt. You may even be transported to the jail, still in handcuffs. Don't argue with it, just live with it. It is not the end of the world.

It is okay to tell them that you are the victim and that you are the one that called 9-1-1. Just understand that police officers, in the course of their duties, are told all sorts of things. What they seek are independent facts from the scene and from witnesses that tell them what really happened. It is not uncommon for police officers to apologize to crime victims, once the facts have come out, for taking them down. The best thing that you can do is be cooperative.

Eventually, someone is going to advise you of your Constitutional Rights and attempt to interview you. This is where it is critical that you have already sought the advice and guidance of a criminal defense attorney prior to carrying your defensive handgun. You should use the earliest opportunity to contact that attorney and get him or her down to talk to you and be present when the police question you.

People who have gone through the traumatic experience of having to shoot another person are under a huge amount of stress. In most cases, it will be more stress than they have ever experienced before. And they are under more stress than they realize and often more stress than they care to admit. This is not a good time to be trying to explain why you used lethal force.

Be polite to the interviewing officers, but tell them that you are very upset and stressed out. Tell them that you intend to cooperate with them but that you simply want your attorney present before you make any sort of statement—verbal, written or video. This is not the time to say things that you might regret later, or things that, given time, you would have said better

forced to draw from concealment. Thinking back, I remember days when I had to use my nondominant hand or eye and fell to pieces. Fair weather habits are tested when the rain is horizontal and the mercury drops. Shooting any discipline will build your skill at arms while providing a barometer to measure yourself against. Some day when you feel you have reached a pinnacle, watch Julie Golob or Rob Leatham. Both of these folks can gracefully humble the best shooters at your home club.

I have long held a belief that shooters are some of the best mannered, friendliest folks going. I have showed up short of equipment and been loaned everything I forgot. I have had friends on opposite relays watch my daughter and share their lunches. Shooters are some of the most even-tempered sports enthusiasts going; compare this

to the parents of some little league games. The comradery I experience at any competition rounds out desire to continue in any discipline. As a new shooter just entering the sports, push the "I believe" button and walk in the door. After that first bout of courage crossing the threshold, you will be rewarded and welcomed into The Family.

Col. Jeff Cooper held among his ideals that young men should be taught to Ride, Shoot Straight and Speak the Truth. This ancient Persian concept became the title of Col. Cooper's second book. Whether you compete or not, please purchase a copy and read it several times. I hope one day to see my daughter develop and mature with the help of shooting sports and The Family. I will thank Norm Truax who held the first small bore silhouette matches I ever competed in. Since

Norm, many others have given of their time and talents to make the sports viable. We owe it to the generations ahead to beat the political flack and continue our national skill at arms.

I agree with a favorite quote from President Theodore Roosevelt (while remembering we need to encourage both genders to join in). "The great body of our citizens shoots less as times goes on. We should encourage rifle practice among schoolboys, and indeed among all classes, as well as in the military services by every means in our power. Thus, and not otherwise, may we be able to assist in preserving peace in the world ... The first step—in the direction of preparation to avert war if possible, and to be fit for war if it should come—is to teach men to shoot!"

and more clearly. It also gives you time to replay the entire episode in your mind and to better remember all of the facts involved.

What I have just described in the aftermath of a defensive shooting is

not what most folks want to have to consider. But it is the reality of what could very possibly happen. If you consider it and expect it, you will have a better chance of dealing with it in as positive a manner as possible. And this is the reason that the aftermath of a defensive shooting should be a critical part of your personal defense plan.
