At the end of 2020—after having been laid up for most of the year with COVID and Long COVID—I said to myself 2021 has to be better because it just can't get any worse and I was right.



Self-Protection and Preservation Starts with Training

"What would you think of me buying a gun?"

It's not an unusual question to populate my phone during the average week. Most times this comes from a younger friend, or someone referred to me from a family member who I have trained. Sometimes fellow shooters who I know well, call for advice or opinions about a particular firearm; this time it was a colleague with whom I had never shot. Within a few days another trusted colleague from a parallel industry had called wanting to get a pistol permit and pistol.

For the past two years, people seem to be waking up to the idea that the police have no specific duty to protect any one person. Other folks have had abundant free time and the ability to take on a new hobby or recreational activity. Always one to encourage a new shootist and advocate for early training intervention, I have cringed with the new prices that shooters have had to pay for guns. Early in the COVID pandemic, I remember the single mom who paid nearly \$5 a round for 12ga buckshot, and the engineer friend enthusiastically telling

me about a great deal on .22 ammo for just under \$100 a brick. Thankfully, I have avoided most new purchases while prices have been elevated.

The simplest question becomes a stumbling block. I have learned to lead up to my answer, and after a little warm up, I respond: "What do you want to do or accomplish with this gun?" I still squirm and feel discomfort when some folks feel the need to whisper when admitting to the desire for increased personal security.

Before we talk about firearms, we talk about, critical thinking, situational



awareness, lighting, locking home and auto doors and not looking like an easy target. Anyone who has read and internalized our own Declaration of Independence and U.S. Constitution should not shirk the ideas of selfprotection and preservation. Talking about hardware (guns and ammo) is fun, sexy and great to engage in with fellow shooters. With folks new to the sport, I try to stick to safety, behavior, mindset and training. Even if you are prior law enforcement/military, if you show no willingness to train, the conversation and my advice ends abruptly. For the female friend, age appropriate to be my mother, the idea of training and a support system eased her mind. She will get to the guns and trigger time, but she is on a smart path with her willingness to learn.

A baby boomer I first interacted with professionally has become a friend. He was a Clifton Park kid long before the malls, shopping centers and pavement. Now with grown children and some discretionary funds he has found a passion in shooting. Autumnal hours of his childhood included a tube fed .22 and hunter education training. As an engineer, he recognized my approach when we first discussed his goals and aspirations with shooting: Step No. 1—Define the problem.

Now with a year of rekindled excitement, this near-retirement friend is planning shooting-related expenses into his budget. I wish I had been there for his first Light Rifle in-door match a few weeks ago, but I was on a ski trip. With only time, male ego and \$5 for entry at stake he took a Saturday and ventured into a new challenge. Hitting a target offhand at 50 feet



is simple to all but those who have tried it. Each target he shot improved, but the necessary scope adjustments seemed odd. We spoke over the phone while I skied, and two days later these adjustments made sense. A text arrived on my phone, in which he told me his scope had crept forward off the dovetail rail leaving a freefloating front ring. Above all, he stayed safe, shot well and will hopefully never miss loose-scope mounts again. Like a new car owner or motorcycle rider his voice leapt through the phone as he praised the shooters who ran the match and those present on the range. "It was great," was all I needed to hear to know he was hooked and was thriving on the mental challenges of shooting in competition.

I have written and preached about teaching the younger generation to shoot. Prior to COVID, I had written an article after interacting with an inner-city couple at a range who were trying to increase their personal safety with a firearm. Now I have a crescendo of boomers who want in or back into a sport we love. Help them, encourage them and include them in your mentorship. Money seems to be less of a concern for many and the dedication to *learning right* has been a blessing in my interactions.

With our current political winds, we need shooters of every age, gender and category. We can shift thinking of those willing to listen as we teach safety, respect and fun. Women On Target courses have long made inroads with often forgotten potential shooters. I continue to rely on Boy Scouts, summer camps and 4H to engage many kids interest in firearms. Make sure we also mentor at the water cooler, church, fire house, legion hall and barbershop. Teach your children well; don't forget to help your peers.

10 Top Pistols for 2022

Though the 9 mm chambering still dominated many of the new offerings, we found a few surprises along the way at the 2022 SHOT Show.

It's always fun to peruse the aisles at NSSF's SHOT Show and handle an array of new offerings. While there were plenty of new calibers and other line extensions being offered, we did find a few surprises along the way, like a new chambering in some of the most current popular models of semi-automatic pistols, and more new models from some of America's oldest gunmakers. Of the dozens of new guns we handled, check out 10 of our favorite semi-automatics.

EAA Girsan MC1911 SC Ultimate

The EAA Girsan MC1911 Ultimate is not new for 2022. But with no 2021 SHOT Show, the pistol is new to us, and we think definitely worth highlighting in this crop of new offerings. After all, stumbling across a nifty single-action 1911 was like finding an oasis in the black polymer striker-fired desert. Optimally sized for concealed carry, this pistol has received praise for both its ergonomics and aesthetics. Besides the obvious factors—fully melded frame/slide; G10 grips with a visual capacity window; and custom texturing—the aluminumframed Ultimate is offered in the standard 1911 caliber (.45 ACP) with a 6+1 capacity and also in 9 mm (7 +1). Other options include a plate for a Far-Dot red-dot optic (which can be ordered with the pistol). Equipped with a 3.4" barrel, the pistol has an overall length of 7" and weighs in at 1.6 lbs. At only 1.22" wide and having a 6 lb. 7 oz. trigger pull, size and



weight make this a great candidate to ride in a holster or stash in a purse. We look forward to pulling the 1911 trigger on this one later in 2022. Finishes are Blue/Black or Flat Dark Earth. MSRP: \$732 (\$833 with reddot optic). EAACorp.com.

Kel-Tec P15

What better way to celebrate your 30th birthday than to give yourself a new gun. And that's exactly what Kel-Tec did when it produced its first strikerfired pistol—the new P15 9 mm. Turns out the company dresses up nicely for its own party (albeit a few years late). For starters, how about a tritium + fiber-optic front sight with a fully adjustable, tritium, two-dot rear sight? Add in a 15-round magazine for a 15+1 total capacity and you are now meeting or exceeding the compactcarry competition. A flush-fit 12-round magazine makes the configuration even more compact. Dimensions are as

follows: 4" barrel length; 6.6" overall length; 5" height; and an incredibly thin .0875" width round out the size specifications. A 5-lb. trigger pull should offer a light squeeze. We were shown some other cool features on this pistol at SHOT Show 2022, but we'll wait to explain those after we've had a chance to fire it. The pistol is expected to be available second quarter of this year. MSRP: \$425. KelTecweapons.com

Kimber Mako R7

Another manufacturer a little late to the striker-fired pistol party is Kimber, but they have a good excuse, having built its brand producing and perfecting some famously nice 1911s. In late 2021, Kimber introduced its third striker-fired but its first polymer pistol—the 9 mm Mako R7—reviewed by contributor B. Gil Horman (www.nrawomen. com/content/5-reasons-to-check-

out-the-kimber-r7-mako-9-mmpistol). As Gil reports, the gun is loaded with features, most notably its ambidextrous, no-snag controls; a "just-right" lighter trigger (about 5 lbs.); an optional intuitive red-dot sight system; and other popular features like a stainless-steel slide and barrel; and two double-stack magazines (a 14-round extended and a 12-round flush fit). The 18 women who fired this pistol in our 4th Annual Ladies Pistol Project were pleasantly surprised at the low recoil produced by such a small pistol and, because we included the red-dot optic, found their confidence boosted by being able to hit their targets where they intended. MSRP: \$599 (optics ready), \$799 (optics included). KimberAmerica.com

Mossberg MC2sc

America's oldest family-owned gun company has been making up for lost time, introducing its third pistol in three years (after not having a handgun in its lineup for a hundred years). We at NRA Women reviewed Mossberg's MC2c (www.nrawomen.com/content/ mossberg-s-just-right-mc2c-9-mmpistol), a compact striker-fired, polymer framed 9 mm, which, as we have noted, turned out to have a great balance of features for home-defense or concealed carry. In 2021, red-dot optics-ready pistols and double-stack magazine "micro nines" were all the rage, which continues into 2022. All Mossberg needed to do was put together all their features in the same package to go forth with the launch of the new MC2sc pistol. One of the most important changes from the first iteration to the current is magazine capacity—now at 14 rounds with the extended mag; 11 with the flush fit mag. Additionally, the top of the MC2sc slide is milled to accept the smaller micro red-dot optics with a JPoint or Shield profile. Ammunition capacity, reliability and red-dot optics ready slide make this pistol ready to

take on the competition in the growing self-defense market. MSRP: starting at \$556. Mossberg.com

Savage Stance

After more than a century without a handgun in its catalog, Savage Arms recently announced a new EDC handgun. Stance, a micro-compact 9 mm, marks Savage's return to concealed carry and self-defense, and is said to be the first in a complete family of handguns. While we await our sample pistol to test fire, here's what we know: Stance utilizes a chassis as the serialized component of the pistol, which allows the flexibility for a wide variety of grip frames. The pistol comes with two interchangeable backstraps, both at the popular 18° angle. Other features include an ambidextrous magazine release and slide catch; stippling grip texture; a stainlesssteel slide with Melonite finish; a beveled front slide; ported, wide slide serrations; short, crisp trigger with short reset; 3.2" stainless steel barrel; removable chassis for interchangeable grips; easy takedown with takedown lever; and snag-free functional sights. Ambidextrous manual safety and night sight models are available. Magazine capacity options range from 7, 8 or 10-round. A package option includes a Viridian E-Series Red Laser. MSRP: starts at \$478. SavageArms.com

Smith & Wesson CSX M&P SC30 EZ M&P Shield Plus SC30

Smith & Wesson brought an array of new pistols and line extensions to its invitation-only range session during SHOT Show 2022, and we've selected three that most piqued our interest.



First up is the CSX micro-compact (www.smith-wesson.com/product/ csx), an aluminum alloy-framed pistol chambered in 9 mm Luger, and boasts an impressive 12+1 capacity (or choose the 10-round magazine for deeper concealment). NRA Women Editorin-Chief Ann Smith fired several magazines through the CSX—and kept going back for more, reporting negligible recoil and incredible ease of use and functionality. Serrations on top of the slide, along with flared rear slide serrations, add to the ease of use and function. A flat-faced trigger, an optimal grip angle and interchangeable backstraps all contribute to yet another winning combination of features on a gun that women will want to shoot. MSRP: \$609.

Smith & Wesson is only one of two firearm manufacturers producing pistols chambered in Federal's new 30 Super Carry cartridge (www. nrawomen.com/content/meetvou-in-the-middle-federal-s-new-30-super-carry-cartridge), which falls somewhere in the middle of specifications for the .380 ACP and 9 mm Luger. And, what better pistol to chamber this exciting new round in than one of S&W's most popular polymer semi-automatic pistols, the M&P EZ. It's impossible not to love the award-winning EZ line. While the much beloved original .380 ACP model released in 2018, followed two years later by the more powerful 9 mm self-defense chambering, will continue to find favor with women, the new 30 Super Carry chambering could soon surpass them in popularity, as the in-between size (www.nrawomen. com/content/meet-you-in-themiddle-federal-s-new-30-super-carry-cartridge/) allows for two additional rounds to be loaded, which could make the difference in self-defense situation. Smith-Wesson.com

Another surprise at the range session was the M&P Shield Plus chambered in the new 30 SC. There is virtually no difference with this pistol in the new chambering—other than it can accept 12+1 and 15+1 rounds versus 10+1 and 13+1 in the 9 mm model. This gun scored high marks in the 4th Annual Ladies Pistol Project (9 mm), so we can't wait to include the 30SC in our next event. MSRP ranges from \$553 to \$595, depending on sight options (white dot versus optics-ready). Smith-Wesson.com

Springfield SA-35

In her review of the Springfield SA-35 (www.nrawomen.com/content/ the-sa-35-springfield-armoryrevives-the-iconic-hi-power), NRA Women contributor Holly Marcus said that when Browning announced in 2017 that the Hi-Power was being discontinued after 82 years of continual production, "it seemed like it would remain an object of obscure desire for most of us." But, all of that changed at the end of 2021 when Springfield Armory announced it was rolling out its own iteration of the iconic design. Made in the U.S.A., the new SA-35 features subtle but significant upgrades, including rugged forged steel parts, improved ergonomics and enhanced controls, modern sights, an improved feed ramp design, and an increased 15-round capacity. The pistol is also configured without a magazine disconnect

for a drop-free magazine. MSRP: \$699. Springfield-Armory.com

Stoeger Sub-Compact STR-9

Stoeger Industries has extended its compact STR-9 series of semiautomatic to include sub-compact models, the STR-9SC Sub-Compact and STR-9SC Sub-Compact Optic-Ready. Based on the original STR-9 compact 9 mm introduced in 2019, the new sub-compact handguns fit the criteria of a deep-concealment defensive pistol, yet offers features similar to what one would expect in a larger handgun—but at a more palatable price point. Like their siblings, the guns are built on an ergonomic polymer frame with a striker-fired semi-automatic action. Notable features include a fiberglassreinforced polymer receiver with steel inserts; Nitride finish; and aggressive front and rear slide serrations. All three subcompact models (Standard, Tritium night sights or Optics Ready) come with a medium backstrap, left- or right-side position magazine release lever, trigger safety, integrated accessory rail, front post/square notch rear sight configuration, and a 10-round magazine for 10+1 carry. The Optics-Ready model comes with a factory-milled optic cut in the slide and four mounting plates with patterns to accommodate the most common micro-red dot optics. Dimensions are 6.54" overall length, a 3.54" blued stainless-steel barrel. The unloaded weight is 22.4 ozs. MSRP \$329-\$399. StoegerIndustries.com.

Your Firearm After You Die

Making plans for the inevitable is something few people want to discuss or disclose. However, the targeted audience of this admonishment are gun owners.

A many of us know: Family members don't always handle a deceased person's property the way the property owner intended. This can be especially true for any owned firearms. While you may want that old Winchester to go to your nephew, another family member may scrap it or sell it off for a pittance because he or she didn't understand its value.

Therefore, *you* must take it upon yourself to decide the fate of your collection—who will safeguard those items, and who will execute your will. I cannot emphasize the importance of perfectly clear documentation to indicate who is to receive what—if anything at all. If you're along in years, consider giving it to them now, so you can experience the pleasure of gifting. It'll mean so much more to both of you.

If you have no one who wants or is eligible to inherit your guns, I have a few suggestions:

No. 1: Donations. The NRA has a program to accept donated firearms. After examination, the association may auction them off and utilize the money for educational purposes. Personally, I would like to see this program adopted by NYSRPA. Truth be told, there are board members who have federal firearm licenses who operate gun shops that could accept the guns and send the ensuing funds to NYSRPA or a specific program, but I digress.

No. 2: Consignment. Find a reputable dealer who is willing to take consignment (especially for handguns in New York state). The standard is to receive the gun, appraise it and place it for sale, collecting a percentage after the sale for doing so. In my opinion, this is the best option as everything will be done lawfully. Plus, the dealer is going to ask for the best price possible because his or her percentage depends on it, and the whole process usually is easy.

No. 3: Auction companies. There are several well-known auction houses that specialize in estates that contain firearms and accoutrements—you didn't think about all those reloading components and equipment, did you? Representatives from the company will come in and collect all the items or hold the sale at the house. As a word of experience, I strongly suggest that family members not be present at the auction as there will be strong feelings and possible pain if some items are sold for pennies. However, at the end of the event, the survivor(s) will receive a check.

A word about the legal responsibilities

Regarding handguns, New York state's SAFE Act outlines the transfer of a handgun after the owner's death. What follows is a brief excerpt from a trust attorney's website and it should inspire you to get the ball rolling unless you want New York state to decide for you:

Pursuant to the NY Safe Act, when a gun owner dies, the law states that within fifteen (15) days of the death of the owner, the person in charge of the decedent's personal belongings must either: 1. lawfully dispose of the gun(s); or 2. turn the gun(s) over to the police. Failure to do so can result in a charge of Criminal Possession of a Firearm in the fourth degree, a class A Misdemeanor, punishable by up to one year in jail or three years of probation, plus a \$1,000 fine.¹

Again, a New York state licensed dealer should be able to help you. Additionally, some counties allow dual registration, which makes the process even easier.

Eventually, we all will die. And, with diseases such as COVID-19—which literally have people here today, gone tomorrow—make sure your wishes are understood by someone you trust, or else the state's going to do it for you.

Opinion: The Right to Own Firearms is as American as Apple Pie

A recent article in *The Wall Street Journal*¹ shared the results of an October 2021 Gallup poll regarding firearms in America. While the number of respondents who say they own a firearm has remained steady for more than a decade (31%), what has changed is Americans' support for tougher firearm control measures—it's declined.

The number of respondents who favor tougher control measure has fallen to its lowest level since 2014—52% of adults in this country want stricter firearm laws, which is down from 67% in 2018. Additional findings in the poll support this feeling as Americans purchased a record number of firearms in 2020, as violent crime rates have begun to rise—the number of homicides increased almost 30% in 2020, compared to 2019. In the past year, the violent crime rate rose 5.2%, while the property crime rate dropped 8.1%.

In fact, 88% of the respondents to the Gallup poll say that they own their firearms to protect themselves against crime—this number has jumped by two-thirds since 2005.

Not surprisingly, the feelings about stricter firearm control measures are divided among party lines—only 24% of respondents who identified as Republicans are in favor of stricter measures and 11% of American adults want less restrictive laws. Additionally, only 19% of the poll respondents support a ban on handgun possession—this is the lowest-ever percentage recorded by Gallup in response to the issue.

Lack of support from the top

President Joe Biden has charged Congress to pass new firearm restrictions, which would include expanded background checks and a ban on semi-automatic firearms with high-capacity magazines. Biden's initiative was sparked by several mass shootings last spring. To give some perspective to the current state of background checks: In 2020, the number of federal background checks for firearms purchases was 21 million—a record high according to an analysis by the National Shooting Sports Foundation, an industry trade group.

The statistics highlighted in this article make it plain to me that firearm ownership is one of our most critical freedoms in America. This freedom is as American as apple pie and the flag! By carrying and using firearms for lawful purposes, honest men and women exercise their liberty every day. We must always guard that freedom and never lose sight of its original purpose as enshrined in the Bill of Rights! It means we can defend ourselves, our property and our country from enemies either foreign or domestic.

As always, may God watch over and protect the brave men and women serving us, at war, in our patriotic Armed Forces and may God bless America!

Which brings me to my next point. Bring some extra dollars for any gun clubs or organizations that might be there and support their fundraising efforts. Yes, of course it's a donation and you might not win what is being raffled off, but every dollar is a winner because you are literally supporting the future of the shooting sports. The money raised is going to support shooting sports programs, range improvements and all sorts of great projects. So, please don't just walk by and ignore them. Even if they are raffling off a gun that you are not interested in, you can always sell it if you win.

Every gun show is a celebration of freedom, liberty, and a reminder that you are not alone. So, get out there, and I'll see you at the next show!

Let's vote to help empower the best patriots! Let's help to get out the NRA vote!



There are millions of people who stand between Democrats and their agenda to end the NRA. Tom King is one of them, and I know you are too. Please remember to vote. Please remind your



SAFS: Offering Instruction to NYS-RPA Members for 22 Years

offered the U.S. Service Rifle Small Arms Firing School to its members. This two-day course is designed to provide you with the basic knowledge required to safely compete in a High-Power Rifle Match. During the program, participants are instructed on firing from position—both slow and rapid fire—with only sling support. Participants are instructed on the AR-15 A2 Service Rifle with iron sights, exclusively. Scopes are permitted in actual NRA and CMP competition, however, the course concentrates on the fundamentals by using iron sights for the course. Our host, The Peconic River Sportsman's Club has National Match AR-15 A2 rifles for loan at no additional charge.

For the last 33 years, the NYSRPA has

The school provides detailed blocks of instruction on safety, sight alignment and adjustment, trigger control, match operations, and the fundamentals of marksmanship. This program is approved by the Civilian Marksmanship Program, and it fulfills one of the requirements for purchasing firearms from the CMP.

Our lead instructors are current or past members of the NYSRPA Service Rifle Team. Many are nationally ranked competitors as well as Distinguished Riflemen. Our team also is supplemented with volunteer competitors who hail from throughout New York state.

You will receive one-on-one marksmanship instruction. The two-day course consists of a half day of

classroom instruction followed by dry-fire exercises from position on the range. A short qualification course also will be fired at 50 yards using the AR-15 platform with a .22 rim fire upper. On the second day, you will fire on a modified CMP course at 200 yards using the AR-15 Service Rifle.

Throughout its 33-year history, we have put approximately 2,000 people through this course. Many have gone on to compete and win at the national level. The dates for 2022 are April 30 and May 1. The attendance for this course is limited to the first 66 qualified entries. It will sell out quickly. You will find a registration form in this issue of *The Bullet*.

I hope we will see you there!
